## DESCRIPTION

*FlyCut*<sup>®</sup> PstI is expressed and purified from *E.coli* that carries the recombinant PstI gene. The molecular weight is 38.3 kDa, with the recognition site at CTGCA<sup>^</sup>G. The reaction is conducted for 5-15 minutes at 37°C, and heat-inactivated at 80°C for 20 minutes. This enzyme is not sensitive to dam, dcm or mammalian CpG methylation.

16 hours Incubation	In a 50 $\mu$ l reaction system, 10 units of enzyme are incubated with 1 $\mu$ g DNA for 16 hours. The result is comparable with that of 1-hour incubation with 1 unit of enzyme.	Met standards
Ligation and Recutting	Digested with a 10-fold excess of endonuclease, more than 95% of the DNA fragments can be ligated with T4 DNA ligase at 25°C, and 95% of the ligated fragments can be recut.	Met standards
Terminal Integrity	The linearized plasmid containing the LacZ $\alpha$ gene (the only site) is religated and transformed on a plate coated with X-gal/IPTG. The successful expression of $\beta$ -galactosidase is the criterion for detecting the integrity of the gene after cloning. Blue colonies indicate the integrity of the gene, while white colonies which indicate the gene is damaged must be less than 3% of the total number of colonies.	Met standards
Endonuclease Activity	In a 50 $\mu$ l reaction system, incubation of 15 units of enzyme with 1 $\mu$ g of pBR322 DNA at 37°C for 4 hours results in no more than 10% from RFI to RFII.	Met standards
